# Explanatory Notes

**General Fee** is a non-refundable, annual amount to cover costs common to students; i.e. student accident insurance, textbooks, student association fees, school yearbook, and items listed in the school bulletin.

**Tuition per student and general fee** must be paid in advance to meet student visa requirements.

## Refund

1. If Immigration Canada should decline the student visa application, the tuition and busing amounts paid in advance will be refunded less the application fee amount (original copy of rejection letter from the Embassy required).
2. If the student withdraws prior to date of enrolment 2/3 of the tuition and busing fees are refundable.
3. If the student withdraws within one month of admittance 1/2 of the tuition and busing fees are refundable.
4. No refund on fees after one month of attendance at school.

**B.C. Resident Rate** becomes available at the beginning of the next full semester after establishing residence in British Columbia.

**Family Discount:** on tuition for the second child is \$1,500. Tuition discount for the third child is \$2,500. Tuition discount for the fourth child is \$3,500. Students must all be from the same family to qualify for these discounts.
